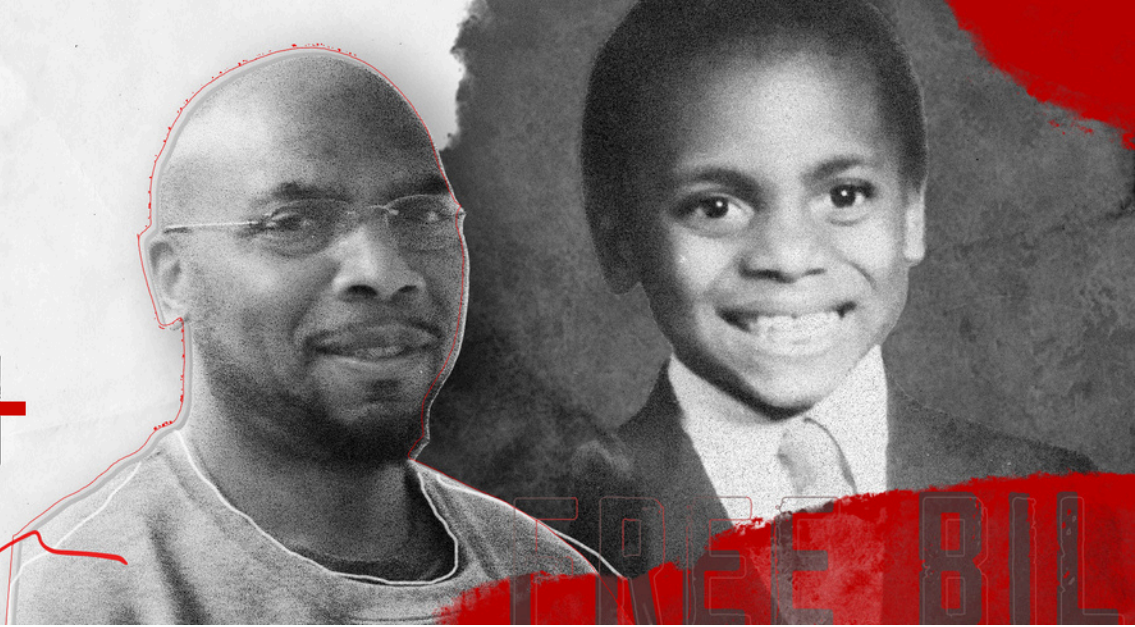

THE WRONGFUL CONVICTION OF BILLIE ALLEN

Billie Allen was wrongfully convicted in 1997 of a robbery-murder of a bank security guard which took place at the Lindell Bank & Trust in St. Louis, Missouri. Despite an alibi witness statement that placed him miles away at the time, and DNA and physical evidence indicating his innocence, Billie was sentenced to death.

BACKGROUND:

From the beginning, Billie's trial was plagued with errors, and the courts severely failed him in their neglect to consider all the relevant evidence.

Evidence that could have exonerated Billie over 26 years ago was available, but was not sought out or presented, thus sealing his fate: For the reasons described below, Billie's conviction and sentence is a miscarriage of justice. First, critical DNA evidence that could prove Billie's innocence has never been tested. A bloody strap found at one of the scenes of the crime was tested for Billie's DNA, and based on that testing, he was excluded from being a contributor. The Government, however, failed to further test the strap, which could have led to the identification of the true culprit. The Government also failed to produce DNA results from a damp rag that was found on the route taken by one of the fleeing suspects. This too could identify the fleeing suspect. Billie has repeatedly asked for these items to be tested but the Government has refused to test these objects. There is also a credible alibi that was disregarded. A security guard, who saw Billie at a mall at the time of the crime. His statement was never admitted into evidence or considered at trial.

We are asking President Biden to please exercise his power of clemency and grant Billie Allen a full pardon from his wrongful conviction and death sentence.

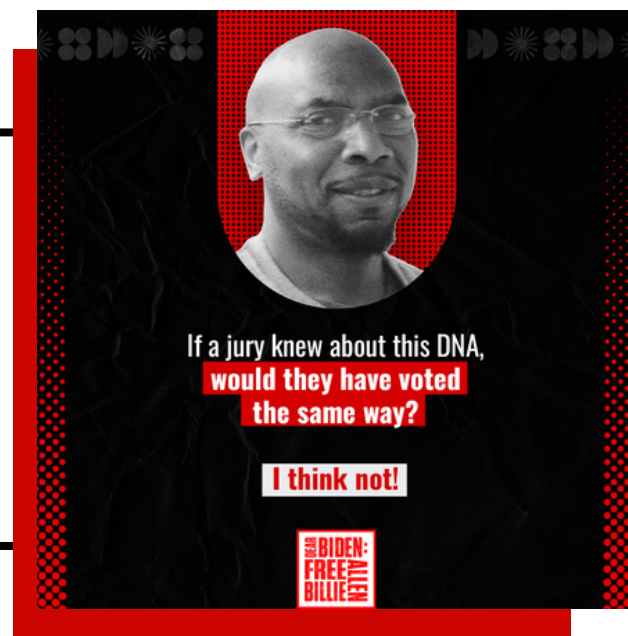
